It is important to note that the Village is a small community with very few, if any, opportunities to consolidate services. We already have contracted fire service agreements with neighboring municipalities and the MDNR, statewide mutual fire agreements, management of elections (Maple River and McKinley Townships), police protection provided by the County sheriff and share an assessor with McKinley Township.
